## RELEASE AND WAIVER OF LIABILITY AGREEMENT RELEASE AND WAIVER OF ALL CLAIMS

I hereby apply to participate in the Gus Macker 3-on-3 Basketball Tournament (the "Tournament"), **Jackson, MI** on **July 23-25, 2021**.

I understand that participating in the Tournament will expose me to above normal risks of injury or harm. These risks include uneven or hazardous playing surfaces, physical contact or collisions with other players, spectators or inanimate objects on or about the court. I understand that the sport of basketball is in itself hazardous and may result in serious injury and/or death to me or other players.

I acknowledge that I am aware that there are risks to me of exposure to directly or indirectly arising out of, contributed to, by, or resulting from an outbreak of any and all communicable disease, including but not limited to, the virus "severe acute respiratory syndrome coronavirus2 (SARS-CoV-2)", which is responsible for Coronavirus Disease (COVID-19) and/or any mutation or variation thereof.

I represent that I have no health or physical problems that will interfere with my participation in the Tournament.

I agree that I am responsible for my own safety.

I hereby assume all risks associated with my attendance and participation in the Tournament. I understand that I am solely responsible for any injuries or illnesses which may occur to me as a result of my participation in the Tournament and I specifically waive my right to bring litigation against the sponsors and specifically release any right to the fullest extent permitted by law which I have to assert a negligence claim against the Tournament, the Tournament sponsors, their agents or representatives.

I understand and agree that by signing this document, if I am exposed or infected by SARS-CoV-2, COVID-19 and/or any mutation or variation thereof during my participation in this activity, then I may be found by a court of law to have waived my right to maintain a lawsuit against the parties being released on the basis of any claim for negligence.
